With over 30 years of experience working in hospitals and physician practice environments, Davidson is a respected leader with a reputation for building great health care teams. Prior to joining Regional Health 3 years ago, she was with Nebraska Medicine, an academic health system where she held the role of system Chief Human Capital and Patient Experience Officer. Prior to that, Davidson was Chief Executive Officer for their Bellevue Medical Center. While at Indiana University Health Goshen Hospital, in Goshen, Ind., she fulfilled several senior leadership roles, including Chief Operating Officer and Vice President of Hospital Operations. She also worked in key leadership roles at Cancer Treatment Centers of America in Zion, Ill. , and Midwestern Regional Medical Center in Zion, Ill.

Davidson is a Fellow in the College of American Health Care Executives (FACHE) and Certified Member of the American College of Medical Practice Executives (CMPE).
